Definitions

Personal data means any information relating to an individual which enables that individual to be identified, directly or indirectly.

GDPR is Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation).

Data subject means a natural person whose data is or may be processed by Swixx Biopharma. In this Privacy Notice, the data subject may be referred to as "you", "you", "you", etc.

Website - the website at www.swixxbiopharma.com.

Counterparty means a legal entity with which Swixx Biopharma has or intends to have a contractual legal relationship.

Partner means the legal entity for whose benefit Swixx Biopharma provides services and who are listed on the Website.

Service Provider means a natural person who provides the agreed services under a contract with Swixx Biopharma. A service provider may be referred to as a consultant, advisor, speaker, author, etc. in different contracts.

Reporter means a person who contacts Swixx Biopharma to report a side effect of a Product, to make a quality complaint or to obtain medical information about a Product.

Product means a medicinal product, medical device, food supplement or cosmetic product represented by Swixx Biopharma.

Product safety means information that is provided in the form of a side effect report, quality complaint or request for medical information about a Product.

An HCP is a healthcare professional (doctor, nurse, pharmacist, etc.).

A contract is an oral or written agreement between two or more persons.

Swixx Biopharma Group of Companies is a group of legal entities whose list and contact details are available on the Website (https://www.swixxbiopharma.com/en/countries/).

Swixx Biopharma Partner means a legal entity whose Products are represented by Swixx Biopharma and may be listed on the Website.

Who is the controller of your personal data?

Swixx Biopharma is the controller of your personal data and can be contacted here: https://www.swixxbiopharma.com/en/countries/cee/lithuania/#lithuania.

In case you submit a side effect report, quality complaint or request medical information about a specific Product, the controller of your personal data is the marketing authorization holder or manufacturer of the relevant Product. In this case, Swixx Biopharma is the data (sub)processor.

What personal data, for what purpose, on what legal basis and for how long Swixx Biopharma process your personal data?

In order to provide easily accessible information, you can select a category of data subject to see what personal data Swixx Biopharma may process, for what purpose and on what legal basis and for how long, from the list below:

CANDIDATE FOR A VACANCY

Categories of personal data processed:

- Information you provide when applying for a specific vacancy, such as your name, email address, telephone number, education, professional experience, language and other skills, or any other information you provide on your CV or at interview.
- Information provided by you or your previous employer, i.e. name, job title, period of employment and
 any other information specified in your previous employer's reference. We may only ask your previous
 employer for a reference/recommendation about you if you have given your consent to this.
- A record of your progress in our recruitment process, i.e. your name, the role you applied for, the time of the interview and any other personal data obtained from you that may be used in our records.
- Your feedback on the recruitment process, i.e., your full name, the position you applied for, the stage
 of the recruitment process you reached, your assessment of the recruitment process, suggestions for
 improving the recruitment process, and other information you provide in the evaluation questionnaire.

Purposes of processing personal data:

- Assessment of the qualifications and skills required for the proposed job.
- Communicating with you about the recruitment process (emails, phone calls, SMS).
- Completing questionnaires and tests.
- Verification of recommendations.
- Storing your personal data in our database so that we can assess in future whether you meet the requirements for the vacancy and contact you if we think that you are a suitable candidate.
- Collect feedback on participation in the recruitment process.
- Assess candidates' satisfaction with the recruitment process.

The legal basis for processing personal data is your consent. By applying for a vacancy, you consent to the processing of your personal data. In the event that Swixx Biopharma wishes to contact your former or current employer and/or store your personal data in a database for the purpose of contacting you in the event of a future vacancy, we will ask for your separate consent.

We will process your personal data related to the evaluation of the recruitment process on the basis of our legitimate interest in improving the recruitment process and its organization to better meet the expectations of candidates and improve the individual experience of interaction with Swixx Biopharma.

Retention period of personal data:

- If you accept the offer of employment, all relevant personal data collected during the recruitment process will become part of the employee's personal file and the data collected during the recruitment process will be kept for 6 months after the termination of the employment contract.
- If we do not recruit you, your personal data will be retained beyond the period during which you may
 lodge a complaint with the competent authority about the recruitment process in accordance with
 applicable law.
- If we do not recruit you but you consent to us storing your personal data for the purposes of assessing
 your suitability and contacting you in the event of a vacancy, your personal data will be stored for as
 long as your consent is valid. However, personal data may be stored even after you withdraw your



consent if such personal data is necessary for Swixx Biopharma to establish, exercise, or defend legal claims.

Please note that if you accept the offer of employment, we will ask you to complete a conflict-of-interest form in order to prevent conflicts of interest, identify potential conflicts of interest and address them in accordance with applicable national and international laws and the Swixx Biopharma Group Code of Business Conduct. After you have completed the questionnaire, we will process the following personal data about you:

- Full name.
- Information about received gifts, even a minor one, excessive entertainment or substantial favours from any outside Swixx Biopharma or individual that does or is seeking to do business with Swixx Biopharma, or it is competitor, that appears to be given with an expectation of reward or influence.
- Information about involvement in any associations with any other companies or organizations.
- Information about serving a director, consultant, agent or employee of any enterprise that seeks to compete with Swixx Biopharma.
- Information about serving a director, consultant, agent or employee of any enterprise that seeks to conduct business with Swixx Biopharma.
- Information about having second job.
- Information about serving director or board member in the Board of Directors of any other company or organization, including non-profit organization.
- Information about having any ownership interest, substantial interest in any concern that conducts or seeks to conduct business with Swixx Biopharma, whether as a supplier, dealer or customer, or as a competitor (except in the case of a publicly owned corporation whose securities are traded on the open market).
- Information about having an ownership interest in a company or organization that operates with the Government or in a company that delivers products or services to Swixx Biopharma.
- Information about having relationship with the renowned person in the healthcare area at the national or the regional level.

Retention period of personal data:



- Personal data processed on the basis of your consent is kept for as long as your consent is valid, but Swixx Biopharma may decide to delete it earlier when it is no longer needed by Swixx Biopharma or personal data may also be stored even after you withdraw your consent if such personal data is necessary for Swixx Biopharma to establish, exercise, or defend legal claims.
- Personal data processed on other grounds shall be kept for the period specified in the Index of retention periods for internal administration documents approved by the Lithuanian Chief Archivist under the Order No VE-50 of 24 September 2024, or until the legal regulation allows a legal action/complaint to be brought before a court.

It should be noted that in accordance with the Law on Pharmacy and the Description of the Procedure for Providing Information on Transferred Values to Recipients, Data of Legal Entities and Personal Data of Healthcare and/or Pharmaceutical Specialists to the State Medicines Control Service under the Ministry of Health of the Republic of Lithuania and the Publication of Information on Transferred Values and Personal Data of Healthcare and/or Pharmaceutical Specialists, approved by Order No. V-1537 of the Minister of Health of the Republic of Lithuania of 23 June 2020, the values transferred to you will be published on the website of the State Medicines Control Agency under the Ministry of Health of the Republic of Lithuania and on the Website for at least 3 years.

- The information you provide in your feedback on your interaction with Swixx Biopharma, for example
 the type of interaction with Swixx Biopharma, your feedback on the interaction, suggestions for
 improving the interaction.

Purpose and legal basis for processing personal data:

- Preparing, concluding and executing a contract with you (for example, sending you an invitation to sign the contract electronically, paying you a remuneration, recording the result of the service in video or audio recordings or photographs and publishing them as provided for in the contract). If Swixx Biopharma processes special categories of data, such as data relating to your health, such personal data will only be processed with your consent, which you may withdraw at any time.  claims.
- Personal data processed on other legal grounds shall be kept for the period specified in the Index of retention periods for internal administration documents approved by the Lithuanian Chief Archivist under the Order No VE-50 of 24 September 2024, or until the legal regulation permits a court action/complaint.

Purpose of processing:

Please note that the processing of certain of your personal data (for example, your identification data) is necessary for the performance of legal obligations and that if you do not provide the necessary personal data, Swixx Biopharma will not be able to conclude a contract as it will not be able to properly perform its legal obligations.

- Location of accommodation.
- Date, time, place of event/meeting.
- Email address and phone number.
- Dietary requirements.
- Signature (only for the HCPs).



• Information you provide in your feedback on the event/meeting, e.g. whether you were a speaker at the event, how many days you participated in the event, how you rate the organization of the event/meeting, what suggestions you have for improving the event/meeting and its organization, etc.

Purpose of processing:

- Arrange transportation, accommodation, meals and other services and/or goods related to participation in the even/meeting, depending on the number of participants.
- To secure attendance of the participant.
- · Register participants.
- To report the expenses in accordance with Swixx Biopharma's internal rules.
- Present/publicise Swixx Biopharma and its activities and events/meetings.
- Get feedback on the event and assess whether participants were satisfied with the event.

Grounds for processing personal data:

- Your consent to the processing of personal data relating to dietary requirements. Consent considered as obtained if you specify any dietary requirements, such as vegetarianism, lactose intolerance, nut allergies, etc. You may also be photographed, filmed or otherwise recorded during the event with your consent, unless such recording is carried out in a public place without requiring the consent of the individual (in which case your personal data is processed on the basis of Swixx Biopharma's legitimate interest, which is to present and publicise Swixx Biopharma and its activities). In the event that you do not consent to being filmed, photographed or otherwise recorded during the event, Swixx Biopharma may ask you to wear a sign informing about the prohibition to be filmed, photographed or otherwise recorded during the event. Please note that you may withdraw your consent to the processing of personal data at any time.
- Compliance with legal obligations related to bookkeeping as stipulated by the Financial Accounting Law, the Profit Tax Law and other relevant legislation and the participants of the event, i.e. Registration of the HCPs as regulated by the Rules on Advertising of Medicinal Products approved by Order No V-1128 of the Minister of Health of the Republic of Lithuania of 28 December 2006.
- Swixx Biopharma' legitimate interest in (a) organising the event in accordance with the number of participants, i.e. organising accommodation, catering, transfers, activities, using Swixx Biopharma's funds in a reasonable manner, and reporting the expenses in accordance with the Swixx Biopharma Group of Companies internal rules; (b) ensuring transparency of hospitality provided at a business-related event and ensuring the reasonableness of the use of Swixx Biopharma's financial resources; (c) improving the organisation of events in order to better reflect the expectations of the participants in the future.

Retention period of personal data:

- If your personal data is processed on the basis of your consent, such personal data will be retained
 for as long as your consent is valid, but Swixx Biopharma may decide to delete it before it is no longer
 needed by Swixx Biopharma or personal data may also be stored even after you withdraw your
