Hailing from Agen, France, Jean-Michel started his career at Laboratoires UPSA. After the purchase of UPSA by BMS in the mid-nineties, Jean Michel moved through a series of finance positions in BMS Central and Eastern Europe, culminating in his promotion to be BMS's GM Russia for six years. In 2006, Jean Michel left BMS and joined Delta Medical (an \$80 million USD turnover specialty pharmaceutical company in Ukraine and CIS). In 2009, Jean-Michel moved to A&D Pharma, where for six years he was Chief Operating Officer of that company's Marketing & Sales Division.

Petr Nemeč, co-founder of Amicus, a major shareholder and current CEO, will step back into a strategic role at the company. He will remain active both operationally and on the Board. The Board would like to thank Petr for his critical contribution as CEO "at the creation" of Amicus, and express its satisfaction that he will remain at the company as a key team member.
